OUR SPEAKERS



Hana Niebur, MD, FAAP, FAAAAI

Dr. Niebur is an assistant professor of Pediatric Allergy and Immunology at UNMC College of Medicine. She completed her medical degree at the University of Nebraska College of Medicine in Omaha, Nebraska, and a residency in Pediatrics at Advocate Christ Medical Center in Oak Lawn, Illinois. She then completed a fellowship in Allergy and Immunology at the University of South Florida and All Children's Hospital in Saint Petersburg, Florida. Dr. Niebur's areas of clinical interest include primary immune deficiency, asthma, food allergies, and atopic dermatitis. Research interests include outcomes and quality improvement in primary immune deficiency and the role of the microbiome in chronic sinusitis. Dr. Niebur is the Asthma Medical Director at the Children's Specialty Clinics in the Pulmonology, Allergy, and Sleep Medicine Division.



Joyce A Baker MBA, RRT, NPS, AE-C, FAARC

Joyce is currently the Asthma Clinical Program Coordinator at the Breathing Institute at Children's Hospital Colorado. She is the inpatient asthma care coordinator and asthma program coordinator. Joyce collaborates with hospitalists, specialists, primary care providers, school nurses, and community health workers to standardize care for children with asthma and other respiratory diseases through guideline-based care. She is co-chair of the Colorado Asthma Coalition, a member of the Colorado American Lung Association - Lung Health Committee, and a panel member through the American Association for Respiratory Care (AARC) and Pediatric Acute Lung Injury and Sepsis (PALSI) Network where she is helping to develop a Pediatric Critical Asthma guideline. Joyce has several publications in the Journal for Respiratory Care on asthma and other pediatric respiratory diseases. She has provided interviews to the media on various health concerns impacting asthma and has presented at local, state, and national conferences on topics specific to respiratory care in pediatric patients and health disparities in asthma. Her national representation includes being a Board of Trustee member for the National Board for Respiratory Care (NBRC), she is on the Asthma Education Certification exam committee, a committee member for the AARC Position Statement Review Committee, and an Editorial Board member for the Respiratory Care Journal.



Jessica Witt, PharmD, BCACP

Dr. Witt received her Doctor of Pharmacy from the University of Missouri-Kansas City in 2016. She is a Clinical Assistant Professor at the University of Nebraska Medical Center (UNMC) College of Pharmacy. She teaches Pharmacotherapy courses on Asthma and COPD medications as well as clinical skills assessment.



Abby Drobny, PharmD

Dr. Drobny received her Doctor of Pharmacy from the University of Nebraska Medical Center (UNMC) in 2024. She is currently a PGY1 Pharmacist Resident in the UNMC-Bakers Community Residency Program and works in the Nebraska Medicine Outpatient Pharmacy. She has worked in the outpatient setting as a technician, intern, and pharmacist for more than five years. Her advanced pharmacy practice experience included the UNMC Specialty Pharmacy and Walgreen's Specialty Pharmacy.



Lauren Maskin, MD

Dr. Maskin is a New York native who first developed an interest in medicine through the study of anthropology with a minor in Culture, Health, and Science at Smith College in Massachusetts. She worked briefly in cardiovascular thoracic research where she became convinced to stick with pediatrics. She is a medical graduate of the Columbia College of Physicians & Surgeons. She trained in Pediatrics at Montefiore Children's Hospital in the Bronx for her intern year and finished her residency training in pediatrics at the Children's Hospital of Philadelphia. Dr. Maskin has been practicing at Children's Nebraska since early 2012 and became a board-certified Pediatric Hospitalist in 2022. She served as the Medical Director for Inpatient Medical-Surgical Services for 9 years and is now the Medical Director for Clinical Effectiveness, where she works closely with the Children's Quality and Patient Safety team.



Joel Van De Graaff, MD

Dr. Van De Graaff is an Assistant Professor of Allergy and Immunology at the University of Nebraska Medical Center. He completed his medical degree at the University of Utah in Salt Lake City and a dual residency in internal medicine and pediatrics at the University of Nebraska Medical Center. He then completed a fellowship in allergy and immunology at the University of Iowa in Iowa City. Dr. Van De Graaff has a special interest in pediatric food allergies. He sees patients at Nebraska Medicine, Veteran's Affairs Hospital, and Children's Specialty Clinic.



Jill Reel, MD

Dr. Reel graduated from medical school at the University of Nebraska Medical Center in 1989 and completed her Pediatric residency at the University of Nebraska Medical Center and Creighton University in 1992. Growing up in Iowa and then Nebraska, she had a lifelong history of allergies, sinusitis, bronchitis, and asthma. She had a few hospitalizations as a child that piqued her interest in medicine, and by age 5, she knew she wanted to be a doctor. In 2019, she was diagnosed with severe COPD, even though she was never a smoker. She started a biologic in 2019, and she believes it has saved her life and greatly improved her quality of life.



Russell J. Hopp, DO, FAAP, FAAAAI

Dr. Hopp graduated from Creighton University and the College of Osteopathic Medicine and Surgery. After a Pediatric residency and 2 years of general pediatrics, he entered an Allergy Fellowship at Creighton University. At its completion in 1984, he started an academic practice at Creighton University School of Medicine, Department of Pediatrics, where he remained for 35 years. He recently moved to UNMC as a Professor of Pediatrics and maintains clinical responsibilities as the Allergy Medical Director at the Children's Specialty Clinics, in the Pulmonology, Allergy, and Sleep Medicine Division. He is Board-certified in Pediatrics and Allergy and Clinical Immunology. Dr. Hopp has over 300 peer-reviewed publications, chapters, and abstracts, and hundreds of presentations, regionally, nationally, and internationally. His allergy specialty areas include severe asthma management, food allergy, and eosinophilic gastroenteritis.



Rachel Shirk, EdD, RRT-NPS, AE-C

Dr. Shirk is the Respiratory Therapy Director at Children's Nebraska, where she oversees the inpatient, pulmonary lab, and outpatient home healthcare respiratory teams. With over 20 years of experience, Rachel has been involved in asthma care through many avenues. She continues to look forward to greater community support for asthma patients, families, and the many people helping these patients.



Heather Bohan, BS, RRT-RPFT, AE-C

After being diagnosed with severe persistent asthma when she was 5 years old, Heather's dream job was always to work in an asthma clinic. The clinic staff always made her appointments fun, even when she was having difficulties. As an adult, Heather went to school to be a respiratory therapist and thinks that having asthma helped her relate to the patients and how they feel. Her goal during testing patients is to make it fun and relatable for kids while trying to get the best results for the provider to ensure the correct treatment plan. Heather has been a respiratory therapist for 18 years. She is a Certified Asthma Educator and a Registered Pulmonary Function Technologist. She is currently the Respiratory Supervisor at Children's Specialty Clinic Pulmonary Function Lab, and Children's Home Health Care.



Leilanie Perez Ramirez, MD, MS

Dr. Perez received her medical degree from the University of Puerto Rico School of Medicine in San Juan, PR, and her Master of Science in Clinical and Translation Research at the University of Cincinnati, OH.
